## What We Know (Barb)

### What is this fly?

### Penn State has positivity identified as "Megaselia halterata mushroom fly"

- This fly is a "filth fly" breeds in moist organic, decaying matter
- Eric Toedter (Kaolin) American Mushroom Institute confirmed mushroom homes are the primary breeding sources of this filth fly
- Climate Change extending growth and breeding season, ie: warming trends
- Need 20 days of below zero to kill off in-ground secondary breeding sources
- Tracking fly counts to see if temperature, humidity, rain, wind, time of day, etc.does not provide any accurate prediction of phorid fly activity
- Dr. Nina Jenkins has now confirmed there are TWO different shapes of this same fly!

#### Health Risks - Phorid flies are considered "vectors"

- · Can carry diseases and bacteria
- Capable of laying eggs in open wounds, and unwashed hair
- · Can contaminate food by landing and crawling on kitchen counters and food

## What We Know

#### **Limited Controls**

- · Professional pest treatment: Interior house spraying
- Spraying house with Dawn/Water
- Treating lawns, mulched beds with Pesticides, NEEM OIL Mix, IGR's
- Sealing holes and gaps around the house
- Keeping All Sink, Shower, Tub Drains Clean
- Keeping Sump Pump, Crock and Condensation Pumps Clean
- Fogging the attic
- Blacking out windows, Room Darkening vs. Light Filtering Shading
- FlyWeb Fly Lights

## Our Next Steps ... possibilities

**Black Fly Suppression Program** – Ben Russell - PA Dept of Environmental protection (Barbara)

### **Green Fertilizer and Lawn Pest Control** (Margo)

- Bifenthrin (Environmentally safe pest treatment) on grounds
- Costs per house lawns \$42.00/spray X 4 = \$160.00
- Cost for open grounds \$1,837.00/spray X 4 = \$7,348.00
- Suggested 4 treatments
- Phone: 610-524-2175 X117, speak to Christian Rising



It is critical that you spray BEFORE the leaves begin to cover the grasses. The spray MUST be applied to the grass, not the leaves!

- Use Fly Web lights to help control phorid flies inside your home
- Draw your blinds/drapes
